Non-members in attendance: Richard Dreitzer, legal counsel; Jackie Miklas, board inspector; Allison Tresca, executive director.

The executive director reported to the Board that the applicant called and had an emergency, and therefore would not appear.

Item 12- Applicant Jennifer L. O'Donnell requests to be licensed as a physical therapist. This appearance is necessary to address the applicant's absence from the field.

Motion to enter closed session: Puentedura.

Second to motion: Menicucci.

Passes unanimously.

After returning to open session -

Motion to grant 18 month probationary license upon receipt of primary and secondary supervisors; supervisors required must remain on-site and co-sign all notes; work at least 20 hours per week for the probation to toll; obtain 3.0 units of continuing education; units obtained will count towards the annual license renewal requirement; 1.5 units will apply to renewal period; must appear to be released from probation: Puentedura.

Second to motion: Menicucci.

Passes unanimously.

Item 13- Applicant Anna Marie G. Stack Rivas requests to be licensed as a physical therapist. This appearance is necessary to address the applicant's work history.

Motion to enter closed session: Baum.

Second to motion: Menicucci.

Passes unanimously.

After returning to open session -

Motion to grant 6 month probationary license upon receipt of primary and secondary supervisors; supervisors required must remain on-site and co-sign all notes; work at least 40 hours per week for the probation to toll; must appear to be released from probation: Puentedura.

Second to motion: Baum. Passes unanimously.

Item 14- Applicant Matthew Victor Noake requests to be licensed as a physical therapist's assistant.

Motion to enter closed session: Menicucci.

Second to motion: Baum. Passes unanimously.

After returning to open session -

Motion to grant licensure: Puentedura.

Passes unanimously.

Item 15- Applicant Mindy Oxman Renfro requests to be licensed as a physical therapist. This appearance is necessary due to the disciplinary action taken by another licensing Board.

Motion to enter closed session: Puentedura.

Second to motion: Baum.

Passes unanimously.

After returning to open session -

Board member Puentedura stated that the applicant duly checked the box on the application regarding discipline by another Board.

Motion to license: Puentedura. Second to motion: Sidener.

Discussion: Board member Menicucci asked if the applicant can be licensed with the revocation of her license and the withdrawn reference letter. Board member Puentedura said the matter is with another licensing Board and the applicant had to be honest on her application and she was honest.

Board member Baum stated that the withdrawn reference letter is an issue, as well as the disciplinary action by the Massachusetts Board. Board member

Sidener stated that the applicant had time to pursue continuing education, certifications and schooling, but she did not put that time towards her Massachusetts case. Board member Puentedura commented that the applicant has moved on and there is no reason for the Board to not allow her to move on. Board member Baum stated that a pulled reference is a concern and the only way to know the reason behind the withdrawal is to ask Ms. Brown. It was discussed that Ms. Brown indicated she would appear before the Board only under the order of subpoena. Board member Baum stated that as it is a reference from her supervisor that was withdrawn, that is of concern. It was suggested that the item be placed on hold to allow legal counsel to attempt to contact Ms. Brown via phone.

Ms. Brown was not available.

Motion to table for a special meeting as appropriate; subpoena Ms. Brown to appear: Puentedura.

Second to motion: Menicucci.

Passes with Puentedura, Menicucci, Baum, Sidener. Board member Mukavitz did not vote as she did not hear the entire discussion.

Item 16- Licensee Harvey Shapira requests reimbursement of the \$150 late fee paid for the reinstatement of his physical therapy license. The director advised the Board that the licensee did not renew on-line or via paper renewal and his license expired. The licensee subsequently reinstated his license, which included a late fee of \$150.

Passes unanimously.

Item 17- Complaint Hearings or Review and Approval of Consent Decrees. (Action). Possible closed session for the Board to discuss the character, professional competence alleged misconduct, or physical or mental health of the person as allowed under NRS 241.030.

Case #2011-27 - Anat Yehushua, PT.

Board member Menicucci recused herself from this item as she was the investigative board member.

Richard Dreitzer advised the Board that this case was for failure to change a residential address timely, and a consent decree was offered to settle. The licensee agreed to the terms of the consent decree, which includes a \$50 fine and legal costs.

Motion to approve the consent decree as submitted: Puentedura. Second to motion: Baum.

Passes with Puentedura, Baum and Sidener. Menicucci abstained as the investigative board member.

Case #2010-15 – Alicia D. Thomas, PT. Richard Dreitzer advised the Board members that the licensee was not served the notice of complaint and hearing as her address on file was not correct. The matter will be set for the next Las Vegas agenda.

Case #2011-04 - Mark R. Brandt, PTA.

Board member Sidener recused herself from this item as she was the investigative board member.

Richard Dreitzer advised the Board that this case pertains to a licensee who did not take the required continuing education and had misrepresented his continuing education courses on his renewal application. A consent decree was offered to settle the case and the licensee accepted the terms, including a fine of \$750 and legal costs. The licensee will also take .9 units of board approved education to meet the deficiency and take an ethics course.

Motion to approve: Baum. Second to motion: Menicucci. Passes unanimously.

Item 32- Review and approval of Executive Director's Report as of January 13, 2012.

Motion to approve: Baum.

Second: Puentedura. Passes unanimously.

Item 33- Review and consideration of matters presented by the Nevada Chapter of the American Physical Therapy Association. Sue Schuerman appeared for the NPTA and thanked the board for agreeing to the complaint process against staff members. She stated that the NPTA wants all Board members to review all complaints. She stated that the NPTA had forwarded a complaint to the Board and the licensee reported that only one person spoke to him and his complaint was not resolved. Chairman Sidener stated that the NPTA forwarded a complaint to her 3 weeks after having received it. She personally called the licensee and the issue was resolved with a phone call. She noted that she offered the licensee the opportunity to file a formal complaint and the licensee declined as the matter was resolved to his satisfaction. Ms. Schuerman stated that they want a way to file anonymous complaints. Chairman Sidener stated that in order to investigate any complaint, whether against a licensee, staff or Board member, a formal complaint with details and signature must be received. The Board cannot investigate when there are no details. A licensee, staff member or board member cannot respond to a complaint without specifics. Chairman Sidener reminded the NPTA that a complaint process was in place for over a decade and the process was recently reviewed by the NPTA and their legal counsel, and was fully agreed to in May 2011. She advised that the Board members are calling every new licensee and if there is a process or staff issue, it will be fresh in their minds. Chairman Sidener noted that there is public comment at the beginning and end of each agenda and therefore the NPTA may address the Board at those times. She noted that if there was a specific item the NPTA wanted action on, they should a request to the Board office so the item can be noticed for the public to be aware. She noted that the Board cannot grant specific appearance times as has been requested by the NPTA. Board member Puentedura asked if the complaint policy needs to be changed as the current language is "written complaint" and does not mention a signature is required for investigation. Richard Dreitzer stated that there is a vehicle for complaints to come to the Chairman in many ways. Ms. Schuerman stated they hear process problems and people are fearful to complain. Richard Dreitzer stated that there may be a fear or concern, but if someone is concerned they have to step up and give specifics to get it looked into. He noted that complaints against licensees are required to be signed as the licensees must be afforded the opportunity to address the allegations, and the same is necessary for complaints against staff or Board members. Richard

Dreitzer stated that the language in the complaint policy was agreed to by the NPTA and their legal counsel and does not want to change it unless the NPTA makes a request to do so.

Item 34- The APTA requests that the Board change the administrative code pertaining to continuing education to allow credit for clinical mentors. Board member Puentedura stated that this does not pertain to clinical instructors, but a clinical mentor in a fellowship program. He noted that the placement is not for a student, but a licensee. Sue Schuerman stated that person taking on a mentor would have to give a lot of their time and effort and must be on top of their game to do this. The executive director said a change to the administrative code would be in order and referenced NAC 640.420, NAC 640.450 and NAC 640.460. Board member Sidener stated the Board should gather information as to what other jurisdictions are doing in awarding continuing education units.

Motion to the director to poll the other licensing jurisdictions as to what they are doing in regards to recognizing and awarding units and to add the item to the NAC review list: Sidener.
