BOARD MEETING MINUTES JANUARY 16, 2014

- Item 1- Call to order / roll call to determine the presence of a quorum. After determining the presence of a quorum, the meeting was called to order at 9:29am. Board members present: Board members: Louie Puentedura, PT, DPT, PhD, FAAOMPT, Chairman; Kathy Sidener, PT, Certified MDT, Vice Chairman; Tina Baum, PT, ATC, CLT, Secretary/Treasurer; Jim McKivigan, DC, PT, MPA, MA; Andrea Menicucci, MS, CCC-SLP, Public Member. Non-members in attendance: Richard Dreitzer, legal counsel; Allison Tresca, executive director; Muriel Morin-Mendes licensing coordinator.
- Item 2 Pledge of Allegiance.
- Item 3 Public comment period. There was no public comment.
- Item 4- Licensee Steven Bolick appears for an update on his probationary license, to determine compliance, and to consider changes to the probationary terms.

This item was taken by a court reporter.

During open session:

Motion to revoke the license for failure to follow the Board requirements. He may apply after 2 years, provided he has undergone substance abuse counseling under and treatment under the care of a physician, and has no activity on his fingerprinting report from this date forward: Sidener.

Second to motion: Puentedura.

Passes unanimously.

Item 5- Licensee Vanessa Plotnick appears for an update on her probationary license, to determine compliance, and to consider changes to the probationary terms.

Motion to enter closed session: Sidener.

Second to motion: Menicucci.

Passes unanimously.

After returning to open session:

Motion by member Puentedura to extend the probation by 2 years of part-time work, or 2000 hours equivalent; must complete an additional 3.0 continuing education units, of which 1.5 units must come from on-site courses; volunteer hours can count towards probation, with a limit of no more than half of the

required hours coming from volunteering. The applicant may appear before the Board early if she completes the hours.

Second to motion: Sidener.

Passes unanimously.

Item 6- Licensee Jennifer Leigh Ford appears for an update on her probationary license, to determine compliance, and to consider changes to the probationary terms.

Motion to enter closed session: McKivigan.

Second to motion: Baum.

Passes unanimously.

After returning to open session:

Motion to continue probation until the end of March, provided the documentation to the Board supports the hours have been met: Sidener.

Second to motion: McKivigan.

Passes unanimously.

Item 7- Applicant Sherolyn Chang requests to take the National Physical Therapy Examination for Physical Therapist's Assistants a third time.

Motion to enter closed session: Sidener.

Second to motion: McKivigan.

Passes unanimously.

After returning to open session:

Motion to grant permission to test by the July 8 test date: Puentedura.

Second to motion: McKivigan.

Passes unanimously.

The applicant asked how many units of continuing education she would need. She was advised that the new grads are waived the first year, if licensed within a year of the gradation date.

Item 8- Review and approval of minutes for Board meeting of November 14, 2013.

Motion to approve with changes: Puentedura.

Second to motion: Sidener.

Passes unanimously.

Item 9- Review and approval of executive session minutes for Board meeting of November 14, 2013.

Motion to approve with changes: Menicucci.

Second to motion: McKivigan.

Passes unanimously.

Item 10- Review and approval of minutes for Board meeting of December 12, 2013.

Motion to approve with changes: Menicucci.

Second to motion: McKivigan.

Passes unanimously.

Item 11- Review and approval of executive session minutes for Board meeting of December 12, 2013.

Motion to approve with changes: Puentedura.

Second to motion: Menicucci.

Passes unanimously.

Item 12- Review and approval of Treasurer's Report for period ending November 2013.

Board member Menicucci noted there was no payment on the report for the bookkeeper. The director noted that the bookkeeper bills quarterly so there is no bill for this period.

Motion to approve: Sidener. Second to motion: Menicucci.

Passes unanimously.

Item 13- Review and approval of Profit and Loss Report for period ending November 2013.

Motion to approve: Puentedura. Second to motion: McKivigan.

Passes unanimously.

Item 14- Review and approval of Balance Sheet as of November 2013.

The director stated that the Wells Fargo savings account balance will be transferred into the Wells Fargo checking, and also stated the last CD will mature and those funds will also go into the Wells Fargo checking. Board member Sidener stated she was not sure it was a good idea keeping the Board's funds in one account. The director advised the Board that there is a state statute protecting the funds, irrespective of the balance. The director noted it is much easier to manage one account, which will make it easier for her, the bookkeeper and the accountant. She noted that Wells Fargo has a division for state agencies so they are well-versed on state requirements.

Motion to approve: Puentedura. Second to motion: McKivigan.

Passes unanimously.

Item 15- Review and approval of Treasurer's Report for period ending December 2013.

Motion to approve: Sidener. Second to motion: McKivigan.

Passes unanimously.

Item 16- Review and approval of Profit and Loss Report for period ending December 2013.

Motion to approve: Puentedura. Second to motion: Menicucci. Passes unanimously.

Item 17- Review and approval of Balance Sheet as of December 2013.

Motion to approve: Sidener. Second to motion: Menicucci.

Passes unanimously.

Item 18- Review and approval of Executive Director's Report as of December 31, 2013.

Motion to approve: Menicucci. Second to motion: McKivigan.

Passes unanimously.

- Item 19- Review and discussion on Federation of State Boards of Physical Therapy 2014 budget. The Board reviewed the budget. It was noted that the budget reflects a negative operating income.
- Item 20- Board member McKivigan requests a discussion on placing a PowerPoint presentation on the Board's website pertaining to navigating the National Physical Therapy Examination.

Board member McKivigan stated he was searching for NPTE information for his students, and happened upon the website for the West Virginia Physical Therapy Board which contained a PowerPoint presentation on how to navigate the NPTE. Board member Puentedura offered to create one for the Board. He stated there is a student who will assist him.

Motion for Puentedura to create the presentation: McKivigan.

Second to motion: Menicucci.

Passes unanimously.

Item 21- Review and discussion on the December 2, 2013 APTA memorandum pertaining to continuing competence efforts by state boards/regulatory agencies.

Board member Puentedura stated he thinks it is a bad idea for the Board to limit educational opportunities, and by approving only one entity or one company, that is what happens. He stated that ProCert through the FSBPT is an option, but it should not be the only option. It was noted that this Board has a committee to

recommend approvals, and the Board reviews to ensure appropriateness. It was suggested that perhaps a letter be written to the APTA that the Board agrees that educational opportunities should not be limited in any way.

Motion to have the director write a letter to the APTA in support of their mission to ensure educational opportunities are not limited: McKivigan. Second to motion: Puentedura.

Passes unanimously.

Item 22- The Advisory Committee on Continuing Education requests the Board to review and determine granting continuing education units for the following courses.

OnlineCE.com - Ethics for Professionals 104 / Confidentiality.

OnlineCE.com - Ethics for Professionals 102 / Ethical Prototypes.

Board member Puentedura questioned if a Chiropractor could teach physical therapy ethics. He questioned whether a Physical Therapist could teach chiropractic ethics, and wondered if the Chiropractor Physicians Board would grant approval to a physical therapist teaching it. Board member McKivigan stated he was concerned with a non-physical therapist teaching physical therapy ethics, and although the person teaching the course has a varied background, he is not a physical therapist. He stated that it is pushing the professional boundaries, and reminded the Board that he is a Chiropractor and Physical Therapist, and he is not good with a Chiropractor teaching physical therapy ethics. It was noted that the course description was very broad, and sweeps the APTA into it and calls it physical therapy. A physical therapist does not work within a chiropractor's office, and a chiropractor does not work within a physical therapy setting. The professions are different.

Motion to ask the provider for a detailed description of what is to be taught in each section, and if any content is specific to the practice setting; return the course with the new information to the ACCE for review: Puentedura. Second to motion: McKivigan.

Passes unanimously.

Item 23- Review of letter from the attorneys for the National Center for Acupuncture Safety and Integrity, and review of the Federation of State Boards of Physical Therapy, regarding the sale and use of acupuncture needles for dry needling.

Board member McKivigan noted that the letter is basically a challenge as to the scope of practice, and the FSBPT responded it is within scope. Janelle Lauchman, PT, President of the NPTA, state that they use acupuncture needles in dry needling, it is not a different type of needle. Richard Dreitzer stated that the lawyers are wagging their finger at the Board. Board member Puentedura stated that he liked the FSBPT reply, that lots of things are used in the practice of medicine, and other practitioners that are not doctors use those things. He stated that if it is such an issue, contact the production company and have them call it

a different name. Richard Dreitzer stated that he agrees with the FSBPT analysis, but their letter is not a shield for the Board, it is merely their opinion. Ms. Lauchman noted that the North Carolina Board challenged physical therapists for performing acupuncture;

Motion to review this situation as warranted: Puentedura. Second to motion: McKivigan. Passes unanimously.

Item 24- Review of policy pertaining to licensees offering gift cards for patient referrals.

Richard Dreitzer noted that the policy he drafted follows Medicare guidelines. Board member Puentedura stated that he liked the wording. Janelle Lauchman, PT, President of the NPTA stated that her dentist gives her 2 movie tickets when she refers a patient. Board member Puentedura noted that a gift card is just a thank you, not a payment.

Motion to adopt the policy as written: Puentedura. Second to motion: Sidener. Passes unanimously.

Item 25- Update of activities of Board office.

Winter News Bulletin posted to the Board's website; postcards sent to all licensees directing them to the website. The director noted the office received a few questions on the requirements to post licenses and licensees to wear name tags. She noted that she gave advice, but did not interpret as the law pertains to all health care licensees. The director noted that there were a few inspector applications and those will be presented to the Board in May. She noted that two new inspectors in Reno had taken the inspector training, and the other two were set to attend in late March. She noted that no one had applied for the ACCE vacancy. The director stated that the Board has Quickbooks on-line now and the bookkeeper has full access. She stated that the legislative subcommittee meeting did not reveal what Boards would be part of the next audit. She stated that the website was being updated to include the new requirements for posting agendas and other items.

Janelle Lauchman, PT, President of the NPTA, stated that licensees have contacted her regarding the requirement for name badges. She has been asked if the person's first name on the company shirt, which includes the facility name, would meet the requirement. The director noted that the law requires the licensees full name and licensure designation, so what was described would not meet that requirement. Ms. Lauchman asked how a person could wear a name if they wear a wetsuit because they are treating under water. The director noted that the legislature set this law, and only they can interpret as it pertains to all health care licensees. The law refers to the general public, so a person in a Cirque show knows the person treating them is a physical therapist, so this should not be an issue.

Janelle Lauchman, PT, President of the Nevada Physical Therapy Association, stated that she hates the extra step of mailing reference letters to her students, and it was much easier when she could fax them to the Board office. The director noted that the applicants must submit their reference letters along with their application. The previous process had the applicant provide the contact information for the references, Board staff would create request letters and contact the references directly, and the reference letters would come to the office via fax, mail or email. It was noted that Board staff was spending a great deal of time attempting to contact references, often times having to write, call, and email the references multiple times without success. Applicants often provided incorrect contact information for their references. The Board decided to require the applicant to submit the reference letters with their application to avoid the delay in processing an application, and to put the responsibility to secure the reference letters on the applicant. Board staff noted that many applicants are able to be licensed the same day their application is received due to this process. Board member Puentedura stated that the process works well.
