- Item 3 Welcome new Board member Sherise Smith, PT. Member Smith stated she was licensed in 1988, and originally worked in Las Vegas before moving to Reno. She noted that her specialty is treating brain injuries. She noted that she has always been interested in the Board and their activities, and has monitored meeting agendas for years. She stated she was honored to be a part of the Board.
