No vote may be taken upon a matter raised during a period devoted to public comment until the matter itself has been specifically included on an agenda as an item upon which action may be taken. (NRS 241.020)

4. Review of Executive Director Applications and Determination of Candidates to Interview at Board meeting on October 17, 2017 **(for possible action)**. The Executive Director Recruitment Sub-Committee will review all applications received for the open Executive Director position. The Sub-Committee will

determine which applicants meet the posting requirements and/or which applicants should be selected for interview on October 17, 2017.

5. Public Comment

No vote may be taken upon a matter raised during a period devoted to public comment until the matter itself has been specifically included on an agenda as an item upon which action may be taken. (NRS 241.020)

6. Adjournment (**for possible action**).

The Sub-Committee welcomes public comment at the beginning and end of the meeting during the public comment periods identified on the agenda. Public comment may be limited to three minutes per person, at the discretion of the Sub-Committee Chair. Comments based on viewpoint will not be restricted. At the discretion of the Sub-Committee Chair, public comment may be heard on specific agenda items, when requested. (NRS 241.020, NRS 241.030)

Before the commencement and conclusion of a contested case or a quasi-judicial proceeding that may affect the due process rights of an individual, the board may refuse to consider public comment. (NRS 233B.126)
