The proposed regulations provide provisions for the following:

- A. Qualifications a physical therapist or athletic trainer must obtain before he or she is authorized to perform dry needling.
- B. Procedures concerning the handling of needles used to perform dry needling.
- C. Procedures to ensure that a physical therapist or athletic trainer does not engage in needle retention.
