She believes the FSBPT is going to be pushing for a continuing competency model that looks a lot different rather than just taking continuing education courses, more around engagement. Again no research to show that continuing education classes are keeping them up to date as physical therapists.

Tiffany Barrett says an incentive for the program is so the faculty does not have to be there as it is an unsustainable program offered this way currently. So the point is so the faculty don't have to be there.

The committee decided that this would be an issue they would send up to the board.
