Licensing System Upgrade

The Board will be implementing a new cloud-based software for license applications and renewals in 2023. Thentia Cloud will allow applicants to apply and update their information through a licensee portal, allow licensees to self-serve many key functions and provide public access to public information about licensees.

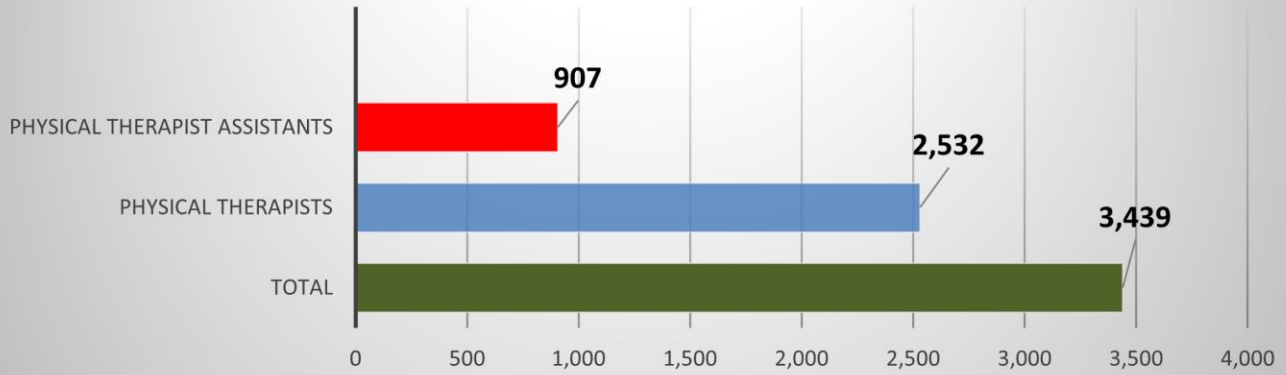

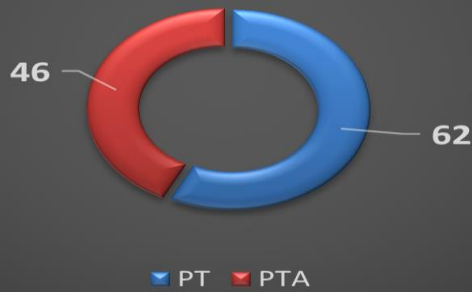
LICENSING STATISTICS

TOTAL ACTIVE LICENSEES

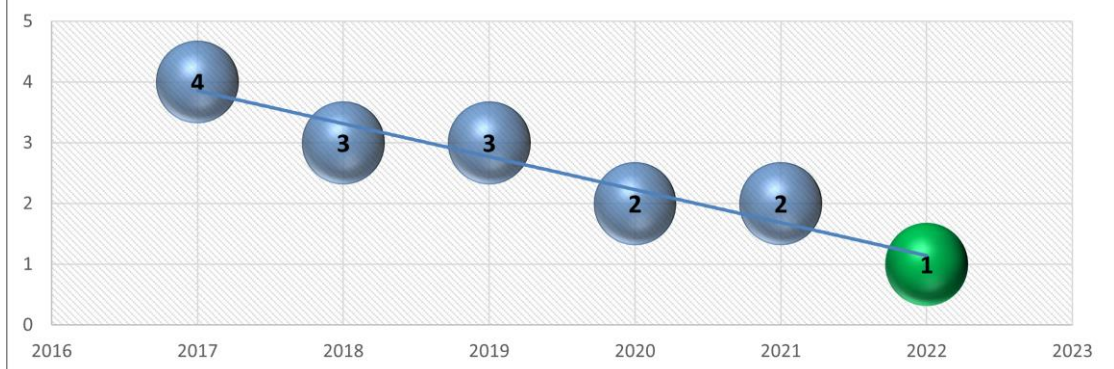


Active Licensees: Military, Veterans & Spouses

The Board's statutory objective is to license and regulate the practice of physical therapy to protect the safety and well-being of the public. To accomplish its mission, the Nevada Physical Therapy Board:

- Promotes legal and ethical standards of professional conduct
- Ensures that applicants meet the necessary education, examination, and experience qualifications to obtain licensure
- Promotes access to care through expeditious licensing of physical therapists and physical therapist assistants
- Ensures licensee compliance with continuing competency requirements to maintain licensure
- Conduct routine inspections to determine compliance with the Practice Act
- Investigates complaints on physical therapists, physical therapist assistants, and unlicensed physical therapy practices
- Proceeds with disciplinary action and issue citations when appropriate

MESSAGE FROM THE BOARD CHAIR



Hello colleagues!

I hope you are having a good end to your year and are excited about the possibilities of 2023. We are excited to announce that on December 5th, the board voted to adopt changes to the Nevada Administrative Code (640). The next step in the process is the legislative commission for final approval. Rest assured; we will notify you immediately when the process is complete.

As the newsletter shows, we have many other new projects on the horizon. We plan to launch our new online portal for renewals this spring, provide support to increase the diversity of our licensees, support a bill to join the PT Compact, and join CE Broker for an easier continuing competence experience. There are many things that won't change in the New Year such as the great customer service from the board office and our commitment to ensuring public protection through such initiatives such as ACCC committee, newsletters, and inspections.

With many thanks to previous board and committee members, Nevada has a holistic approach to continuing competence by offering licensees continuing education credit for working at pro bono clinics, obtaining a specialty certification, and mentoring PTA and PT students. Nationally, the FSBPT Continuing Competence Committee is also looking for other ways to engage professional growth outside continuing education courses. They have worked with researchers at the Colorado State University to develop a new Healthy Practice Self-Reflection Resource. The purpose of this resource is to guide physical therapists and physical therapist assistants through regular, proactive self-reflection that is evidence-based, supportive, modular, and appropriate for all levels of healthy practice. The resource is currently in a testing phase, and they are looking for more participants to access the resource so that they can develop the best product possible. Please consider helping develop this resource by your participation. Your input is incredibly valuable for this research. All submissions are anonymous but if you would like to be entered to win a \$100 gift card there is an opportunity to register for the drawing at the end of the survey. FREQUENTLY ASKED QUESTIONS

Q: Can a PT supervise a PTA across state lines?

A: No. Supervision is part of the practice of Physical Therapy in the State of Nevada and as such has to be performed in the State of Nevada.

Q: Can an out-of-state PT practice physical therapy via telehealth to a patient in the State of Nevada.

A: Nevada's licensure requirements allow out-of-state providers to treat Nevadans, if they have a current license to practice in the state (NRS 629.515(1)).

Q: Is dry needling within the scope of practice of physical therapy in the State of Nevada?

A: Yes. NRS 640.014 defines dry needling as a skilled technique performed by a physical therapist using a single-use, single-insertion, sterile filiform needle, which is used to penetrate the skin or underlying tissue to effect change in body conditions, pain, movement, impairment, and disability.

Q: Is a physical therapist assistant allowed to perform dry needling in Nevada?

A: No. Dry needling may only be performed by a licensed physical therapist after they've received authorization from the Nevada Physical Therapy Board.

Q: How do I find license or discipline information about a licensed individual?

A: You can go directly to the license verification page on the Board website [Nevada Physical Therapy Board \(nvptboard.com\)](http://NevadaPhysicalTherapyBoard.com), and search by Last Name, First Name or License Number.

Q: When does my license expire?

A: Licenses issued prior to October 1, 2017, expire at midnight on July 31st of each year. Licenses issued on or after October 1, 2017, expire 1 year after their date of issuance.

Q: What happens if I let my license expire?

A: You will have up to two years to renew and will need to pay the renewal fees and late fees and satisfy continuing competence requirements for each year.

Q: How do I get a duplicate license?

A: Send a written request for another license along with a copy of your driver's license and a fee of \$25 made payable to the Nevada Physical Therapy Board.

Q: What is patient abandonment, and how do I avoid it?

A: There are three basic elements that must be present in a situation for it to constitute abandonment.

1. You have accepted responsibility for a patient's care. i.e., you are the PT or PTA treating the patient, or the PT supervising the PTA treating the patient.
2. The patient still needs care, and
3. You stop treatment of the patient without sufficient notice to allow a reasonable amount of time to arrange for a new PT or PTA to take your place.

The most important consideration is to make sure you give appropriate written notice to your employer (or your patient if you are self-employed). This allows your employer or the patient sufficient time to find a replacement for you, so that patient care is not disrupted.

ETHICS ARE ESSENTIAL

The Code of Ethics of the American Physical Therapy Association describes the desired behavior of physical therapists in their multiple roles, addresses multiple aspects of ethical action, and reflects the core values of the physical therapist. Fundamental to the Code of Ethics is the special obligation of physical therapists to empower, educate, and enable those with impairments, activity limitations, participation restrictions, and disabilities to facilitate greater independence, health, wellness, and enhanced quality of life.

PRINCIPLE #1: Physical therapists shall respect the inherent dignity and rights of all individuals.

PRINCIPLE #2: Physical therapists shall be trustworthy and compassionate in addressing the rights and needs of patients and clients.

PRINCIPLE #3: Physical therapists shall be accountable for making sound professional judgments.

PRINCIPLE #4: Physical therapists shall demonstrate integrity in their relationships with patients and clients, families, colleagues, students, research participants, other health care providers, employers, payers, and the public.

PRINCIPLE #5: Physical therapists shall fulfill their legal and professional obligations.

PRINCIPLE #6: Physical therapists shall enhance their expertise through the lifelong acquisition and refinement of knowledge, skills, abilities, and professional behaviors.

PRINCIPLE #7: Physical therapists shall promote organizational behaviors and business practices that benefit patients and clients and society.

PRINCIPLE #8: Physical therapists shall participate in efforts to meet the health needs of people locally, nationally, or globally.

WHAT IS THE DIFFERENCE BETWEEN THE PT BOARD & THE PT ASSOCIATION

Many licensees are unaware that the Nevada Physical Therapy Board is separate and unrelated to the APTA Nevada. All licenses in the state of Nevada are regulated and subject to the jurisdiction of the Board based on state legislation and regulation. The APTA NV is the local chapter of the national professional organization, the American Physical Therapy Association. Membership in the APTA NV is voluntary. DRY NEEDLING – STANDARDS OF PRACTICE

Dry needling is a physical therapy treatment that requires specialized physical therapy education and training for the utilization of such techniques. Prior to utilizing dry needling treatment techniques in the State of Nevada, a physical therapist shall meet certain education and training requirements and must obtain approval from the Nevada Physical Therapy Board. To obtain approval, licensees shall:

1. Submit an application to the Board containing proof of successful completion of at least 150 hours of didactic education and training in dry needling. The educational requirement includes at least 25 hours of didactic education and training provided through a postgraduate course of study that requires the successful completion of in-person written and practical examinations.
 - a. The Dry Needling Standards of Education and Training Verification Form shall be submitted to document the successful completion of education and training requirements (Available on the Board website https://ptboard.nv.gov/Licensure/Dry_Needling/)
 - b. Physical therapists who did not attend a master's or doctorate level physical therapy program, and have completed 150 hours of education and training in dry needling which meets the requirements of NAC 640 shall also complete and submit the Dry Needling Attestation Form (Available on the Board website https://ptboard.nv.gov/Licensure/Dry_Needling/)
2. Obtain a signed consent from the patient. The following information must be included on the Dry Needling Consent Form:
 - a. Dry Needling definitions (as listed in NRS 640.014)
 - b. The description of the treatment and the risks/benefits of dry needling; and
 - c. The signature of the patient.

Please note that practicing dry needling without compliance with these requirements constitutes unprofessional conduct and subjects a licensee to appropriate discipline by the Nevada Physical Therapy Board. Contact the Board office at (702) 876-5535 if you have any questions.

CHANGE OF NAME OR ADDRESS – ARE YOU IN COMPLIANCE?

In accordance with NAC 640.055 and NAC 640.061, any change in name, residential address or primary professional address must be submitted to the Board Office within 30 days of the change.

To notify the Board of a legal name change, change in residential or primary professional address, download the applicable form located at <https://ptboard.nv.gov/Forms/Home/>, and return the completed form to the Board office.



SCAM ALERT

The Board continues to get reports of scam calls being placed to our licensees. Some of the callers may claim to be an investigator from the FBI or from a Board Investigator working with a federal agency on an investigation. The callers will threaten loss of license and demand personal information to confirm the investigation or will demand payment. These calls may appear to come from the Board office because the scammers can “spoof” the Board’s telephone number. If you receive one of these calls, or are unsure if a call you’ve received from the Board is legitimate, please hang up and call the Board office at (702) 876-5535 or email pted@govmail.state.nv.us to report or verify the call. 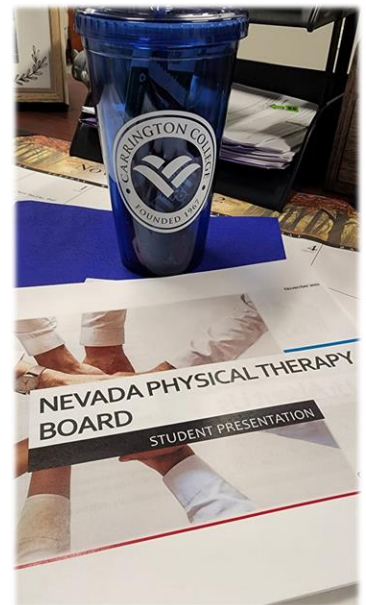
OUTREACH – SCHOOL PRESENTATIONS
