BOARD MEETING MINUTES AUGUST 23, 2013

- Item 1- Call to order / roll call to determine the presence of a quorum. The meeting was called to order at 5:05 by Vice Chairman Puentedura. Board members present in the Board office: Louie Puentedura, PT, DPT, PhD, FAAOMPT, Vice Chairman; Tina Baum, PT, ATC, CLT, Secretary/Treasurer; Jim McKivigan, DC, PT, MPA, MA. Board members from the north appearing telephonically: Kathy Sidener, PT, Certified MDT, Chairman; Andrea Menicucci, MS, CCC-SLP, Public Member. Non-members in attendance in the Board office: Allison Tresca, executive director. Richard Dreitzer legal counsel, appeared telephonically.
- Item 2- Public comment period. Board member Puentedura reported that he attended the 2013 FSBPT Leadership Issues Forum and wanted to provide a brief summary of that meeting. He noted that a detailed report will be provided at the September 12, 2013 meeting in Reno. He reported that the FSBPT is leaning towards a maximum lifetime of 6 attempts at the NPTE. He noted there were very interesting statistics, including that the pass rate decreases with each attempt. He noted that the evidence supports limiting the attempts and the upcoming annual meeting in October will address this issue, so it is not something to delay discussing. Mrs. Tiutiunnyk's husband stated his wife will be testing for the fourth time and he did not believe it was appropriate to bring up these statistics now because she is already very nervous. Board Member Puentedura stated he was not trying to make anyone nervous, he believed the more the applicants know, the better they can make their decision to test.
