Public Comment Procedure:

3. Those individuals wishing to present concerns to the Board are to sign in prior to speaking;
4. Depending on the number of individuals wishing to address the Board, a reasonable time limit may be set. The Board will not restrict comments based upon viewpoint;
5. No action may be taken upon a matter raised during Public Comment until the matter itself has been specifically included on an agenda as an item upon which action may be taken.

Item 5- Applicant Irena Oana Nicoara requests to take the National Physical Therapy Examination for Physical Therapists a third time in accordance with NRS 640.100(4). (Action). Possible closed session for the Board to discuss the character, professional competence alleged misconduct, or physical or mental health of the person as allowed under NRS 241.030.

Item 6- Applicant Jan Francis Chuidian requests to be licensed. This appearance is necessary to address the applicant's work history. (Action). Possible closed session for the Board to discuss the character, professional competence alleged misconduct, or physical or mental health of the person as allowed under NRS 241.030.
