ADVISORY COMMITTEE ON CONTINUING COMPETENCY MEETING MINUTES February 24, 2020

Item 1- Call to order / roll call to determine the presence of a quorum. After determining the presence of a quorum, the meeting was called to order at 10:06 am.

Public: Jeff Mcamman; At Home Seminars Continuing Education Coordinator

Item 2 - Public Comments:

Jeff Mcamman with At Home Seminars explains he submitted 55 course back in July 2019 for renewal and they had not changed since the previous approval and they all came back denied. He explained most are text based courses some with DVD, online content, and videos. The reason these courses were denied was for C.1.P which is for self paced reading of textbooks or chapters of textbooks. He believes this is not an adequate denial for his courses. He said the At Home Seminars courses are organized courses with goals, objectives, and with post tests. He explains people learn better in different ways through different subjects.

Katherine Joines said she will clarify everything under this item at today's meeting.

Jeff points out the board has two pieces of information floating around the white paper and the continuing competency model. He said the information on both these items conflict with each other.

Katherine Joines explains yes she understands that and we are currently in the process

to make sure everything is in line with each other. She then mentions she is going to make sure this is addressed and his concerns are discussed.

- Item 7 -** Review and Discussion on new member policy and open meeting law

The committee reviewed the documents and they all felt it was very helpful and informative.

- Item 8 -** Review and Discussion on the ACCC Model

Discussion:

Jennifer Nash said she doesn't believe any more action needs to take place with the model she feels she understands the direction the committee wants to take and she can address that to the board.

Kirk Sachtler has a concern about board members not getting continuing education due to being compensated.

Jennifer Nash explains the board is also conflicted on this and she will share his thoughts with the board.

Chelsea Wilson questions there not being a max number of units awarded on conferences.

Jennifer Nash explains this is something still being worked on by the board. But there will be a max.

Chelsea Wilson questions if the Jurisprudence is going to be removed from the model.

Jennifer Nash says as of right now it will be removed until a later date however, going with best practice it will eventually be mandated to every 5 years.

Chelsea Wilson asks about residences and fellowships still being a part of the model.

Jennifer Nash explains this is still something the board is discussing but asks the committee for their input.

Katherine Joines suggests giving units for residences for 2 years if they do 2 years.

Beren Shah mentions that previously we had setup the model so that fellowships originally were awarded on year of completion.

Jennifer Nash mentioned she would be bringing up Tiffany Barrett's opinion to the board about degree coursework being awarded for more continuing education credit than originally discussed.

Beren Shah clarified at the last meeting we talked about giving 1 continuing competency unit for one course regardless of how many hours it was.

The committee does ultimately agree that continuing degree work should be awarded for more units depending on the course or hours put into a semester.

Item 9 - Review and Discussion on the White Paper

Item 10 - Review, discussion, and possible approval of the Course Review Refund Policy (**For Possible Action**).

Discussion: Current policy is we give no refunds. Jen Nash suggests that refunds should be Board/staff discretion, but nothing that is reviewed by the committee should be refunded.

Item 11 - Review, discussion, and possible approval of Self-Paced Reading Denial Citing (**For Possible Action**).

Discussion: Per changes to the white paper self paced reading of textbooks, chapters of textbooks, excerpts of textbooks, copies, and reprints are denied.

Item 12 - Review and Recommendation of Previously Denied Courses – Self Paced Reading Denials (**For Possible Action**).

Discussion: Several providers had been previously denied due to their courses being mainly self paced reading type courses. At Home Seminars one of those providers resubmitted several courses in their entirety for the committee to review in an attempt to prove these were not books, but modules. After review the committee still agreed these are chapters of books. Katherine Joines then reads the printing information where it tells what books the chapters are printed from.

Jeff with At Home Seminars asks to clarify and he is given the okay to proceed with clarification from the committee. He explains two of these examples are home study courses not from a book but are text based. The third example is excerpts from a book but have been reorganized into a homestudy course.

Jeff argues that just because a course has self paced reading it should not be denied. When you take courses there are books that you have to read through the duration of the course.

Katherine Joines explains yes you do have to do some reading in courses but it is not solely reading but using the textbook for basic information. Because when you get into class it is not textbook you are heavily relying on but the expertise the handling and actually being able to do the treatments. We wanted to reclarify that when talking about textbooks is not just memorization and regurgitation of the information because that is not true learning.

Katherin Joines further explains that not all textbook reading courses are bad but they want to

see more than just reading from a book and taking a test. She says that some of At Home Seminars submittals appear to be more modular because they contain additional things that aren't just reading like DVD's and additional learning material. She said she will re-review all of his previously denied courses self paced reading courses to ensure whether or not they are modular or are in fact strictly self paced reading.

Item 14 - Public Comment:

Jeff with At Home Seminars said rules are unclear and nothing has been clearly established. The language needs to be clarified as far as self paced textbook reading denials. He is also requesting the courses that At Home Seminars submitted which were denied due to self paced reading be approved due to the fact they have always been approved for the past 2 years. In the future in regard to submissions At Home Seminars could take the self paced reading denial into effect and apply those to the course they are submitting. However, right now he thinks with the unclarity the denial needs to be reversed. He also added the providers need to be notified when these changes are made as he was not notified.

Katherine Joines appreciates the input from Jeff and she said she understands his request to re-review At Home Seminars initial submittal. However, she wants to be very clear that there is now an updated white paper and she will use the white paper that was in effect as to when these submittals arrived in the office. Additionally she did state to Jeff that all providers were sent letters informing them of the change. Lastly, she explains this is a dynamic situation and we cannot stay

in the same position 20, 30, 40 years ago that we need to change as time changes. However she does understand his request and will re-review his courses.
