4. Public Hearing *(For Possible Action)*. Pursuant to Executive Order 2023-003, the Board is seeking input from key industry stakeholders regarding regulations that can be streamlined, clarified, reduced, or otherwise improved to ensure those regulations provide for the general welfare of the State without unnecessarily inhibiting economic growth. The Board will vet the recommended changes and solicit input as to the merits of those changes.

6. Consideration of Public Comments *(For Possible Action)*. The Board will consider regulatory changes that stakeholders feel are worthy of consideration and approve a list of not less than ten (10) regulations recommended for removal, ranking them in descending order of priority.

The Chairperson may allow additional time to be given a speaker as time allows and, in the Chair's sole discretion (NRS 241.020, NRS 241.030).

The Board may discuss matters, not on the agenda but may not act on those matters at this meeting. If the Board desires, the matters may be placed on a future agenda for action.

Prior to the commencement and conclusion of a contested case or a quasi-judicial proceeding that may affect the due process rights of an individual, the Board may refuse to consider public comment. (NRS 233B.126)
