
Vision:

CONTINUING COMPETENCY UPDATE

The Nevada Physical Therapy Board with guidance from the Advisory Committee on Continuing Competency (ACCC) updated the Clinical Competence Model as of 8/1/2020. A total of 15 hours of continuing competency activities are still required for license renewal.

Most Notable Updates!

- APTA NEXT and CSM national courses are automatically ACCC approved courses.
- 2. Non-clinical courses are eligible for ACCC approval up to 8 max/yr.
- Pro-Bono, primary clinical instructor and college coursework have increased value.
- 4. Participation in Residency/ Fellowship are eligible for full 15 units for one yr.

- 5. Passing score of ABPTS certification exam valued at 15 CCUs.
- New CCU Verification Form to properly document advanced competency and professional activities found on the Board website.
- CCU Documentation Table provided on the Board website to clearly explain documentation required at license renewal.

Tips to Keep in Mind when Choosing your next Continuing Competency Course

- Course entailing only self-paced reading of textbooks/ Chapters of textbooks/ Journal article with post-test will be denied.
- Courses not taught face to face MUST have a post-test component.
- The course must be sufficiently rigorous to be contemporary and beyond/above entry level physical therapist or physical therapist assistant practice in any areas of physical therapy practice.

RENEWAL REMINDER

PLEASE ENSURE THAT YOUR LICENSE IS ACTIVE

Each license is active for one year, and must be renewed prior to its expiration date. Licensees may complete their renewal 60 days prior to expiration by visiting http://ptboard.nv.gov and selecting "License Renewal". Licenses may be renewed online and paid via credit card, or by downloading the mail-in renewal and paying by check.

TWO RENEWAL PERIODS

Licenses issued prior to October 1, 2017 expire at midnight on July 31st each year.
Licenses issued on or after October 1, 2017 expire 1 year after their date of issuance.

COVID-19 EXTENSIONS

Licensees who received a COVID-19 extension are reminded to renew their licenses by the end of the extension date provided in their letter from the Board.

NOT RENEWING THIS YEAR?

Please notify the Board if you do not wish to renew your license this year and would like your status changed to "Expired".

BOARD POSITION OPENING

The Board encourages licensed physical therapists to consider applying for a position on the Nevada Physical Therapy Board. The Board consists of five members appointed by the Governor for two-year terms. Members serve the critical role of enforcing the provisions of the Practice Act (NRS/NAC 640), and set and enforce criteria for licensure and practice by physical therapist and physical therapist assistants. The Board holds 6-8 meetings annually, along with committee meetings and conferences. Interested individuals may apply by contacting the Office of the Governor Board's & Commission's page at https://gov.nv.gov/Board/Home_Board/.

PETITION FOR CRIMINAL HISTORY REVIEW

A criminal conviction is not an automatic barrier to licensure. Individuals interested in pursuing a physical therapy career may request that the board review their criminal history to determine if the person is eligible for licensure, based solely on the person's criminal background up to that point in time. Pursuant to NAC 622.085, a person with a criminal history may petition the board at any time including, without limitation, before obtaining any education or paying any fee required to obtain a license from the board. The petition process includes the completion of the Petition for Criminal History Review Form, submission of court documents, a criminal history background check and a fee of \$50. The Board will inform the petitioner of the determination of whether the person's criminal history will disqualify them from obtaining a license within 90 days of receipt of the petition.

ADDRESS CHANGES

Nevada Administrative Code 640.061 requires that licensees notify the Board, in writing, of any change in residential or professional address within 30 days after the change. Please ensure that the Board has your up-to-date information (including email and telephone) so we may communicate with you in an efficient and timely manner

ROUTINE INSPECTIONS


Each year, the Board conducts inspections to determine compliance with all provisions of the Practice Act. The inspection includes a chart audit to ensure the following requirements are being met:

- 1. Initial examination, including identification of a problem list, impairment list, or some form of specific assessment related to a patient's physical therapy diagnosis [NAC 640.590(b)(c)].
- 2. Plan of care including goals, presented with the initial evaluation [NAC 640.590(c).
- 3. PT assessing patient every 7th day of treatment or every 21 days (whichever comes first) [NAC 640.592(d).
- 4. Evidence of patient program review and/or progression [NAC 640.590(g)(h)(i)(j)].
- 5. Evidence of discharge evaluation, report, or documentation reflecting patient discharge [NAC 640.590(i)].
- 6. Notes for care provided are completed with 72 hours of visit [NAC 640.610(1b)].
