The Board continued its mission of public protection through credentialing of new licensees and renewal of active licenses, regulation of the profession and promotion and regulation of continued competence requirements.


The number of licensees continues to increase, as does the need for physical

therapy services in the State of Nevada.

In Fiscal Year 2022, the Nevada Physical Therapy Board added more than 300 new physical therapists and physical therapist assistants. The Board's Advisory Committee on Continuing Competence (ACCC) reviewed and approved over 1,500 course applications.

During this period, the Board also engaged in several significant projects, including:





- Software Modernization: Selected a new licensing system which will upgrade and streamline the online application, licensing, and renewal processes.
- Website Redesign: Improved website layout, functionality, and optimization for mobile devices.



LICENSE APPROVAL BY MONTH




Remember to renew your licenses early. June, July and August represent our busiest workload with more than 80% of licenses expiring during this three-month period. Licensees are reminded to complete their renewal process as early as possible to avoid last-minute system or processing delays. A license may be renewed at any time in the two months prior to its expiration date. Please remember that it is illegal to continue to practice with an expired license.




## LICENSING STATISTICS

## FRADULENT COMMUNICATIONS

The Nevada Physical Therapy Board has been made aware that some licensees have received fraudulent communications from individuals claiming to be from the Board.

#### Please note:

- Phone calls may appear to be from the Board telephone number
- You may verify the identity of a Board investigator or inspector by calling (702) 876-5535 or emailing <u>ptapplication@govmail.state.nv.us</u>.
- The Board will never demand that you provide personally identifying information, such as social security number, date of birth, bank or credit card account numbers over the phone.
- The communication may threaten arrest, demand personal information or require the payment of fines.

The Nevada Physical Therapy Board does not send such communications. If you believe that you are the recipient of a fraudulent communication claiming to be from the Board, you should refuse the demand and contact the Nevada Physical Therapy Board at (702) 876-5535 or ptapplication@govmail.state.nv.us.

## LICENSING SOFTWARE UPDATE

The Nevada Physical Therapy Board is in the early stages of implementing a new licensing database. The Board will be replacing its current database and utilizing Thentia's licensing software and database solution to provide online applications, license renewals and verifications, online payments, CCU tracking and complaint/investigation tracking.





The new modernized system will significantly expand functionality for licensees and offer improved online capabilities. Most notably, the secure online self-serve licensee portal will provide new applicants and licensees with the ability to input and manage their personal and professional profile information, upload/download documents, track and manage continuing competence requirements, apply for new and renewal licenses and make payments. Expected implementation – fall 2022.

## PUBLIC PROTECTION IS OUR PRIORITY

The Nevada Physical Therapy Board is responsible for regulating this profession and protecting the public in matters related to physical therapy. The Board conducts random inspections and investigates complaints to determine compliance. The Board's complaint process is a critical tool in reporting issues concerning inadequate or incompetent treatment, licensee misconduct or any other violation of the laws and rules governing physical therapy. However, it is not limited to patients being treated. According to NAC 640.550(7), each licensee has an obligation to report unlicensed, authorized, unqualified or unethical practice by another person. The Board investigates each complaint and takes appropriate action when a violation of the practice act has occurred.

## BOARD INSPECTORS NEEDED




The Nevada Physical Therapy Board is seeking to fill a part-time intermittent Inspector position. Board Inspectors work on an as-needed basis and

## PT COMPACT UPDATE

The Physical Therapy Compact is an agreement between member states to protect the public by increasing consumer access to physical therapy services by reducing regulatory barriers and increasing the mobility of eligible physical therapy providers to work in multiple states.

The Nevada Physical Therapy Board will be seeking legislative approval to join the Interstate Physical Therapy Compact at the 82<sup>nd</sup> (2023) Session of the Nevada Legislature which begins on



## NAC 640 - PROPOSED CHANGES



The Nevada Physical Therapy Board is making a concerted effort to determine whether proposed regulations are likely to impose a direct and significant economic burden upon a small business or directly restrict the formation, operation, or expansion of a small business. A small business is defined in NRS 233B.0608(1) as a business conducted for profit that employs fewer than 150 full-time or part-time employees.

If you have a small business that may be impacted by proposed changes to Nevada Administrative Code Chapter 640, please review, complete, and return the attached **Small Business Impact Questionnaire.** 

The questions pertain to how the changes in the Nevada Administrative Code presented in the enclosure will affect your business. If it is determined that the proposed regulation is likely to impose a direct and significant economic burden upon a small business; or directly restrict the formation, operation, or expansion of a small business; then the agency will take any or all of the following actions:

- 1. Insofar as practicable, consult with owners and officers of affected small businesses,
- 2. Consider methods to reduce the impact of the proposed regulation, and
- 3. Prepare a small business impact statement and make copies of the statement available to the public at the workshop conducted and the public hearing held pursuant to NRS 233B.061.

BACKGROUND: In 2021, the Nevada Physical Therapy Board put forth proposed changes to Nevada Administrative Code Chapter 640. Public comment was solicited when the Board submitted the proposed changes to the licensing community and other potentially affected parties, to survey their thoughts regarding the proposed revisions. The Board received public comments through workshops and a public hearing before submitting the proposed regulation to the Legislative Counsel Bureau in November 2021. Due to comments that have been submitted since that time, another Small Business Impact Survey is requested.

I am honored to be the current Chair of the Nevada Physical Therapy Board and excited to share a bit with you of what we have been working on.

This year, we welcomed two new members to our board, Jessie Fisher and Aaron Stevens. Both reside in northern Nevada and bring great energy and experience to the board.

- ❖ Jessie Fisher graduated with her Masters in Physical Therapy in 2000 and has worked in the Reno/Sparks area her entire career. She obtained her ABPTS Board Certification in Orthopedic Physical Therapy in 2016 and her Masters in Business Administration from the University of Nevada, Reno in 2018.
- ❖ Aaron Stevens joins our board as the public member. He is a certified Orthotist/Prosthetist who began his career as an occupational therapist. He is also the founder of the RENO SPARKS Ambucs, a service organization that adapts bikes for kids with mobility deficits.

Together, the Board and staff, work daily to enhance services for our members while keeping to our mission of public protection. Most recently our efforts have been focused on upgrading communication through board office wireless access, updating the website, and transitioning to a new software management system. The ACCC committee continues to meet bimonthly to approve valuable and diverse CC courses and are working to improve the CCU list by categorizing approved courses by patient population. Additionally, we are already preparing for the new legislative session where we plan to again bring a compact bill.

Legislative Counsel Bureau feedback on the Nevada Administrative Code (NAC) revisions is expected back this summer and we are hopeful to complete the process this year. This process which began in 2018, updates the code language including removal of the PTA supervision hours requirement.

## **Q**UESTIONS AND **A**NSWERS

## Q: Am I required to do continuing education to maintain my license?

**A:** Yes. Every physical therapist or physical therapist assist must complete 15 hours of approved continuing competence within the year immediately preceding their application for license renewal. Additional information may be found on the Board website at

https://ptboard.nv.gov/Home/V3/Home\_Competency/.

#### Q: How many CCUs do I need every year?

**A:** 15 CCUs (15 hours)

## Q: What do I need to submit for proof of CCU credit for an approved course during renewal?

**A:** You need to submit a signed course completion certificate with the date completed and number of CCU hours stated.

## Q: May I receive 15 CCUs for an APTA nonclinical (business-related) course?

**A:** No, however, 8 hours of a non-clinical course can be applied toward the 15-hour annual requirement.

## Q: How do I report a name change and/or request an updated license?

**A:** Changes in name must be submitted in writing to the Board administrative office, along with documentation supporting the change (i.e., marriage certificate, divorce decree). Please include your name and license number. If you wish to receive a duplicate copy of your license reflecting the updated name, you must specify this in your request and include a check or money order in the amount of \$25.00, made payable to the Nevada Physical Therapy Board.

#### Q: When are licenses renewed?

**A:** Licenses issued prior to October 1, 2017, expire at midnight on July 31st of each year. Licenses issued on or after October 1, 2017 expire 1 year after their date of issuance.

#### Q: What happens if I let my license expire?

**A:** You will have up to two years to renew and will need to pay the renewal fees and late fees and submit continuing competence for each year.

## Q: I am applying for a license in another state and need license verification. How do I obtain this?

**A:** Requests for license verification must be submitted in writing to the Board The license verification form can be found on the Board website. Please include your name, license number and the name and address to which the verification must be sent.


#### Q: How is a complaint filed?

**A:** Anyone, including the Board, may file a complaint against a licensed PT or PTA. The complaint form can be found on the Board website. After receipt, the Board may contact you for additional information.

## Q: I have moved and/or changed my place of employment. How do I update my address with the Board?

**A:** Changes in address must be submitted in writing to the Board administrative office within 30 days. Please include your name, license number, old address and new address. Please also specific if the change is to your mailing or practice address.

# CONTINUING EDUCATION OR CONTINUING COMPETENCE



## Q: Why did Continuing Education Units (CEUs) change to Continuing Competence Units (CCUs)?

**A:** Continuing education is the former term and now the current term is continuing competence as it is more inclusive to other activities besides just educational courses.

Q: How do I know what is approved by the Board for Continuing Competence credit?

**A:** The approved course list can be found on the Board website at <a href="https://ptboard.nv.gov/Home/Vd/Home\_Competency/">https://ptboard.nv.gov/Home/Vd/Home\_Competency/</a>.

Q: Are all APTA sponsored courses automatically on the Board's Approved Course List?

**A:** No. However, on July 22, 2022, the Board approved all American Physical Therapy Association (APTA) Combined Sections Meetings (CSM) and APTA Learning Center courses for continuing competence licensure renewal requirements.

Q: Can I get credit for the Continuing Competence course I teach?

**A:** You can get up to 8 CCUs under the professional activities category. When submitting proof of CCU, make sure to include the CCU verification form for the professional activity along with 7 CCUs from the certified activities category.

Q: What type of activities are approved for CCU credit?

A: Three different avenues (categories) are available to the licensee to obtain 15 CCUs each year.

#### 1. CERTIFIED ACTIVITIES

These activities are conferences or individual continuing education courses that are on the <u>ACCC approved list</u>. Contact April at board office if you have questions about your specific course. If not already on the approved list, licensees may submit a course application. (Fees may apply if not APTA course). Licensees can accumulate a total of 15 CCUs from this category to complete the minimum requirement, unless otherwise specified.

#### **Certified Activities:**

Conferences: As awarded by the ACCC

Individual Continuing Education Courses: As awarded by the ACCC

Non-Clinical Continuing Education Courses: As awarded by the ACCC\* (i.e. Business-related course material)

<sup>\*</sup>Licensees are able to accumulate a MAXIMUM of 8 CCUs from the non-clinical category.

#### 2. ADVANCED COMPETENCY ACTIVITIES

These activities are advanced coursework or specialization in a sub-specialty that demonstrates ongoing, contemporary learning <u>in the field of Physical Therapy</u>. A CCU <u>Verification form</u> is required for proof of activity completion. Licensees can accumulate a total of 15 CCUs from this category to complete the minimum requirement.

#### **Advanced Competency Activities:**

Passing score on the Certified Specialist Examination through ABPTS \*\*

Participation in an Accredited Residency

Participation in an Accredited Fellowship

#### 3. PROFESSIONAL ACTIVITIES

These are activities that the NVPTB has deemed appropriate to receive CCUs without the need for ACCC review. A CCU <u>Verification form</u> is required for proof of activity completion. Licensees can accumulate half their yearly total (**MAXIMUM of 8 CCUs**) from this category towards completion of the minimum requirement.

#### **Professional Activities:**

In-Person Attendance at NPTB/APTA NV meetings: 1 CCU/meeting for max of 4 CCUs/year

NPTB/APTA NV Board/Committee work: 1 CCU/ 5 hours of work for max of 4 CCUs/year

College Coursework: 1 CCU/ credit for max of 8 CCUs/year

In-service (attending an in-service): 1 CCU/hour for max 4 CCUs/year

Pro-Bono PT service: 1 CCU/ event (≥2 hours) for max 4 CCUs/year

Primary Clinical Instructor: 1 CCU/ 40 hours of supervision for max of 8 CCUs

Primary Instructor of Continuing Competence Course: Max of 8 CCUs for the first year a course is taught

Peer-Reviewed Publication: 1 article/year for 8 CCUs for max of 8 CCUs/year

## PRIMARY INSTRUCTOR OF CONTINUING COMPETENCE COURSE

On July 22, 2022, the Board added Primary Instructor of a Continuing Competence Course as an approved professional activity. Licensed clinicians teaching continuing education courses may now receive up to 8 CCUs for the first year a continuing competence course is taught.

<sup>\*\*</sup>Credit is given for the licensing year during which participation in the activity is > 6 months.

## TELEHEALTH

Nevada law defines telehealth as "the delivery of services from a provider of health care to a patient at a different location through the use of information and audio-visual



communication technology, not including standard telephone, facsimile or electronic mail" (NRS 629.515). This statute encourages and facilitates the provision of services through telehealth for public health and to lower the cost of health care in the State of Nevada.

Accordingly, the Nevada Physical Therapy Board recognizes that using telehealth services offers potential benefits in the delivery of physical therapy services. While the Practice Act (NRS/NAC 640) does not specifically address telehealth, NRS 629.515 includes physical therapists in its list of "health care providers". Therefore, licensed physical therapists in good standing may practice physical therapy via telehealth to a patient within the jurisdiction of Nevada.

Nevada law defines telehealth as "the delivery of services from a provider of health care to a patient at a different location through the use of information and audio-visual communication technology, not including standard telephone, facsimile or electronic mail" (NRS 629.515). This statute encourages and facilitates the provision of services through telehealth for public health and to lower the cost of health care in the State of Nevada.

Accordingly, the Nevada Physical Therapy Board recognizes that using telehealth services offers potential benefits in the delivery of physical therapy services. While the Physical Therapy Practice Act (NRS/NAC 640) does not specifically address telehealth, NRS 629.515 includes physical therapists in its list of "health care providers". Therefore, licensed physical therapists in good standing may practice physical therapy via telehealth to a patient within the jurisdiction of Nevada.

#### Key points:

- ➤ A physical therapist must be licensed by Nevada Physical Therapy Board.
- > Both physical therapist and client must be in Nevada when services are performed
- ➤ The practitioner is responsible for determining that telehealth services are appropriate for the client, ensuring that billable services are performed over the telehealth platform, and adhering to applicable laws and standards of care.
- ➤ Please see the following statutes for more information on telehealth in the State of Nevada. NV Rev Stat § 629.515 (2017)



# NEVADA PHYSICAL THERAPY BOARD SMALL BUSINESS IMPACT QUESTIONNAIRE: Proposed Changes to Nevada Administrative Code 640

The Nevada Physical Therapy Board is making a concerted effort to determine whether proposed regulations are likely to impose a direct and significant economic burden upon a small business or directly restrict the formation, operation, or expansion of a small business.

If you have a small business that may be impacted by proposed changes to Nevada Administrative Code Chapter 640, please review, complete and return the attached **Small Business Impact Questionnaire.** NRS 233B.0382 "Small Business defined." "Small business" means a business conducted for profit, which employs fewer than 150 full-time or part-time employees.

The following questions pertain to how the changes in the Nevada Administrative Code presented in the proposed changes will affect your business. If it is determined that the proposed regulation is likely to impose a direct and significant economic burden upon a small business; or directly restrict the formation, operation, or expansion of a small business; then the agency will take any or all of the following actions:

- 1. Insofar as practicable, consult with owners and officers of affected small businesses,
- 2. Consider methods to reduce the impact of the proposed regulation, and
- 3. Prepare a small business impact statement and make copies of the statement available to the public at the workshop conducted and the public hearing held pursuant to NRS 233B.061.
